30 Years in Karate

Henderson, who is a 5th Dan, is marking his 30th year of involvement in karate, either as a student during his earliest years, or since then as an instructor. At present, he teaches at the Southeast Rehab and Wellness Center Lucedale.

His wife, Judy, George County school teacher, was in an exchange teacher program last winter and traveled to Tokyo. While there, she went to a dojo (gym) to work out, which was with a master in martial arts.

Henderson said she was surprised at the similarities in the way the master in Tokyo taught and in the teaching done by her husband, halfway around the world.

Japanese Master

Henderson began his training of the Martial Arts in Shitoh-Ryu Karate in Mobile in April 1971. Hugh Kelly, a 7th degree Black Belt (7th Dan) and John McLain, a fourth degree Black Belt (4th Dan) conducted the training. Henderson was under Seiyu Karate Union directed by Master Shiyogo Kuniba of Osaka, Japan.

Earned 1st Dan

Henderson received his first degree in Black Belt (1st Dan) in Shitoh-Ryu in August 1973. He continued his training at the Mobile Karate Dogo until the summer of 1974, when his occupation moved him to Laurel.

At that time, he began training in Shotokan Karate under the direction of Gerald Giles, 4th Dan, of Hattiesburg. During this


